Any addenda issued during the bidding period will only be posted in the e-Room in a folder titled Addenda and will not be transmitted by any other method. BIDDERS are responsible for periodically checking the e-Room for addenda and ensuring that they have received all addenda prior to submitting their Bid as DSWA may reject any bid for being non-responsive if addenda items are not accounted for in the bid.
